1. Only life members of ISPA are eligible to contest for the office bearers of the executive committee.
2. No member of ISPA can hold same post for more than more than two consecutive terms, irrespective of the nature of the position(s) held.
3. The cutoff date for eligible voters list stand, as on 31.12.2023
4. In case any post remains vacant, the vacancy shall be filled by nomination jointly, by the outgoing committee and newly elected executive committee.

5.	Declaration of final list of valid candidates	15 <sup>th</sup> March 2024
6.	e-voting starting date (if required)	15 <sup>th</sup> April 2024
7.	Closing date of e-voting	22 <sup>nd</sup> April 2024
8.	Declaration of results *	26 <sup>th</sup> April 2024

\*Note - In case elections are not required, the names of the elected candidates will be declared on 18<sup>th</sup> March 2024, 14:00 hrs
